THIS IS A RELEASE OF LIABILITY AND COMPLETE, UNCONDITIONAL & TOTAL WAIVER OF YOUR LEGAL RIGHTS!**

In consideration for my being permitted to participate in the activities of hunting or any activity with Antler Canyon Outfitters LLC, I agree to the following waiver of all my legal rights. I acknowledge that hunting and/or target shooting has inherent risks, hazards, and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. **I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:**

1. The risk of handling firearms and archery equipment and being near others that have firearms and/or archery equipment in their possession.
2. The risk of injury from ammunition, shot, and arrows from firearms and archery similar equipment.
3. Walking and driving in rugged country, including encounters with wildlife, animals and insects.
4. Inclement weather conditions.
5. The risk of injury from riding live mules, horses, all-terrain vehicles or ANY vehicle used on or off a paved rd.
6. The risk of injury from the use of tree stands/ground blinds/stick blinds. Including slip/falls on said equipment.

I understand the risks, hazards and dangers described above and have had the opportunity to discuss them with Antler Canyon Outfitters LLC. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely

voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. **I AM VOLUNTARILY USING THE SERVICES OF ANTLER CANYON OUTFITTERS LLC WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH. FOR MYSELF, MY HEIRS, SUCCESSORS, EXECUTORS, AND SUBROGEEES, HEREBY KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS ANTLER CANYON OUTFITTERS AND ANY GUIDES EMPLOYED BY**

**ANTLER CANYON OUTFITTERS LLC**, their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of actions, liabilities, suits, expenses, (including attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of Antler Canyon Outfitters LLC/or any guide employed by Antler Canyon Outfitters LLC or from some other cause. I for myself, my heirs, my successors, executors, and subrogees, further agree not to sue Antler Canyon Outfitters LLC and/or any guide employed by Antler Canyon Outfitters LLC as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of hunting OR ANY activity with Antler Canyon Outfitters LLC, or any guide employed by Antler Canyon Outfitters LLC. Also, I acknowledge unless stated by me in writing photos/video of my hunt may be used for marketing purposes and my name and phone number or e-mail address may be released to future clients as a referral of Antler Canyon Outfitters LLC. Deposit is nonrefundable. Due to extraordinary circumstances, such as illness, or death ACO will refund deposit, or apply deposit to a future hunt. Determination to refund, or apply deposit to a future hunt is solely at the discretion of ACO management.
